Information and Instructions

To vote at the TIO Limited Annual General Meeting or any other meeting of Members, or to help form a quorum at such meetings, a Member that is a body corporate may appoint an individual as a representative to exercise its powers at the meeting.

The appointment may set out restrictions on the representative's powers. If no restrictions are specified, the representative will be able to exercise, on behalf of the body corporate, all the powers that the body corporate could exercise at the meeting.

The appointment may be made by reference to a named individual or by reference to a position held (e.g. "the company's CEO" or "the company's compliance manager"). If the appointment is by reference to a position held the appointment must identify the position.

A body corporate may appoint more than one representative but only one representative may exercise the body corporate's powers at any one time.

Unless otherwise specified in the appointment, the representative may exercise, on the body corporate's behalf, all of the powers that the body corporate could exercise at a meeting of Members, including voting on a resolution.

To assist corporate Members, a template form of Certificate of Appointment is provided. The template form is designed to create either a standing appointment in favour of the appointee, or an appointment specifically for one particular meeting of Members (depending which box the Member ticks).

If you would like to know whether your body corporate has notified TIO Limited of the appointment of any corporate representative, please contact the Company Secretary (details below).

The appointment of a corporate representative can be revoked by a resolution of the directors of the body corporate. Please notify the Company Secretary in writing of the revocation of any such appointment.
